Council Briefs 12/12/2022:

Public Hearing Rezone: Heimat Properties, LLC (school property) requested rezoning the property from residential to commercial. Council and guests asked a few questions and attorney Roger Hippert was on hand to explain that this property will never be a school, it will not become a residence due to the renovation costs, there may be options if it is a commercial zone. Council approved the rezoning later in the meeting.

Approved the consent agenda: Included in the consent agenda were: 11/14/2022 council minutes, 12/1/ Special Pay Equity minutes, 12/6/2022 Truth in Taxation and budget workshop minutes, bills totaling \$71,503.58 and the three sump pump waivers presented.

Council Briefs 12/12/2022 continued:

Reports: Fox: The city was not awarded either the stormwater or fluoridation grants. The cost of the Fluoridation update was \$4865, council approved the update. The last time it was updated was about 20 years ago. After discussion of the MN Rural Water's program, the consensus of the council was to register for the PFAS Recovery program, at no cost to the city. **Peterson:** Invited all to attend Santa Day & tree lighting. **Burger:** month spent on budget, annual payrolls, year-end reports and preparing for end-of -year and audit prep. **Tauber:** NU Building officials met and will not offer Lafayette building official services. **Klingler:** Someone at UFC is interested in joining the Fire Dept., which would help for daytime calls. Inquired about the city's interest in the rural fire truck to replace the pumper.

Unfinished Business: RO Project: The RO Temp Bond money was received. PFA requested a WIF project information worksheet for real and projected operating costs and was submitted. Council authorized Fox to move forward with awarding the RFP for the RO project's site evaluation, Geo-technical Services and investigation of the old well house foundation location.

Council voted to not move forward to adopting the MN building code. And adopted the Pay Equity Step Plan and Placement for current FT staff.

New Business:

Besides approving the rezoning of the Heimat Property council also set a public hearing for the January meeting for a CUP (conditional use permit) for a new solar garden next to the existing one.

Approved: Resolution 2022-28 – December donations of \$38, Resolution 2022-22 Certify delinquent utilities to the tax roll, Resolution 2022-27 Forgiving the Water fund loan from the Waste water fund. Fire officers for 2023: Chief – Nick Klinger, Asst. Chief – Mark Voges, Secretary – Savanna Clemon, Training Officers Logan Van Deest and Scott Portner, Truck Runners – Wayne Portner and Kenny Liebl, Fire Marshall – Joe Sondag, and resignation of John Richter and Corey Langhoff.

End of Year Moves:

2022 Ambulance assessments: \$ 6522.80 to General Fund Streets to Public Works savings: \$25,000 for street sealing and \$5,000 towards equipment

Revolving loan local Funds to Culture for updates: \$11,957.49 Fire Department to Fire Equipment Savings: \$7,200 General Fund to General Fund Project Fund: \$10,173 remaining donated or grant funds for the band shelter update. Culture porta potties charges coded to ARPA funds of \$1,829 Water Fund to RO Temporary Fund: \$20,000

Resolution 2022-29 – Approved the 2023 budget and adopted the 2023 Property tax levy. General Fund Levy \$175,139, New Ambulance \$6,600 and RS Fiber Debt Service \$35,488 Total: \$218,277 or a \$35,488 increase (16.14%)

Before the final budget and levy were approved there was discussion of the city to use the budgeted mowing funds and purchase a lawnmower for the cost of around \$13,000 and mow in-house. Some felt it a cost saving measure for the long run, as we already pay our employees, others were concerned with after the pay equity hours adjustment, that other things would get neglected. Mowing bids will go out to be returned before the January meeting for further discussion.
