## **Election Fun Facts & Information:**

As more registered voters understand the process of mail in voting, we are seeing higher voter turnout. August Primary: During the August 2018 Primary Election Day, we had 56 of 289 registered voters cast a ballot in person. In 2020 we had 69 of 298 registered voters cast mail in ballots, due to the Pandemic. This year in the August 2022 Primary Election we had 92 of 300 registered voters cast their mail in ballots; Primary Elections went from 19.4% in 2018 to 30.7% in 2022. November General: General Election day in 2018 we had 281 registered voters and 194 cast ballots in person or 69% (non-presidential years were always lower turnout) and 2020's General Election Day (Presidential) there were 313 registered voters and 261 cast mail in ballots or 83.4%. For the 2022 City Elections: we have Mayor Sandie Peterson running for re-election. Council members Tom Polich and Dave Reed running for re-election for the two council at large seats up for election in November, there were no challengers to any positions. Voting: If you are a registered voter your ballot will arrive about a month before the November 8 -General Election Day. To vote, drop your completed ballot in the mail or at the Nicollet County Government Center (NCGC). If you want to vote in person, take your ballot packet to the NCGC the week prior to election day or on election day and vote in person **Registering:** If you are not a registered voter, you can save time on election day by going on to the MN Secretary of State's website to register at https://www.sos.state.mn.us/elections-voting/register-to-vote/ or in person at the NCGC until October 18; registration temporarily closes after that date and will reopen for same-day voter registration at the polling place on the General Election Day. We are a mail in voting precinct, so our designated voting place is at the NCGC.

## We Need Everyone's Help!

DO NOT MOW GRASS CLIPPINGS INTO THE STREET! It is unsafe for motorcycles, bikes and walkers as it becomes slippery and can cause injury accidents. They can also clog the spillways, which can cause flooding or as it flows into the ditches and eventually river can cause issues with algae, etc. MN Statute 169.42 concludes by making it illegal to place on a street or highway state "any other substance likely to injure any person, animal, or vehicle upon any such street or highway."

**What you can do:** Mow the first two swipes into your yard. If you get grass clippings in the gutter or street, simply grab a broom and clean it up, or your leaf blower to blow them back into your yard!

## Council Briefs: 8/8/2022

**Approved** the consent agenda including 7/11 minutes and bills totaling \$47,310.50.

**Guests:** D. Lange – Nicollet County Sheriff, D. Hanson – Winthrop Publications, and R. Lawson – Lafayette Ledger, T. Ulrich – Heimat Properties, LLC, and R Hippert – Heimat attorney. Residents: D. Burger – 580 Main Avenue, P. Ferguson – 711 Lafayette Avenue, M. Aalid – 660 Esther Avenue, T. Myers – 740 Lafayette Avenue, R. Peterson – 670 Esther Avenue, K. Schuelke – 400 Main Avenue, and P. Schuelke – 120 6<sup>th</sup> Street.

**Citizen concerns:** M. Aalid and P Ferguson shared concerns of the property at 691 Lafayette Avenue and that council is not doing enough.

**Reports:** Fox: Will meet w/ Tauber and Polich to go through the service line grant process. Burger: Is working on the 2023 budget, send her your wish lists. Ambulance: Looking for 4 or 5 more members. Have changed the monthly training. Fire department also needs a few more members. Polich: Park & Rec asked about holding a fall soccer session and a Fall Food Truck Friday.

Unfinished Business: RO Water Project: Mayor Peterson read the update of the Congressionally-Directed Spending requests from the Offices of Senator Tina Smith and Senator Amy Klobuchar. "The Senate Appropriations Committee released draft proposals for funding the federal government for Fiscal Year 2023. These drafts include Congressionally-Directed Spending requests that cleared the federal agency eligibility review and were selected by the Senate Appropriations Committee." Included in Senator Smith's and Senator Klobuchar's selected projects was the City of Lafayette's RO Project Request. The Senate, in coordination with the House, continues to work toward crafting an appropriations bill agreed upon by both chambers. This process may go on for several more months, and we will not know definitively about these awards until the process concludes and a bill is signed into law. We will continue to provide updates to those projects involved in the ongoing process. Truck: The Chevy truck will be posted for sale for a minimum bid of \$9,000. Blight Properties: The consensus of council was that 691 Lafayette Avenue had done their due diligence to clean up the property and were working to make updates. Council will proceed for 400 Wanser grass and deck issues;

#### Council Briefs: 8/8/2022 - continued:

Unfinished Business continued: a certified letter to clean up the undergrowth and mow, trim and haul away. A resolution for the removal of the deck would be an action item at a special meeting along with the scheduled budget workshop on 9/15. Mini Park: Met on 7/21 to discuss the paver and design. The push is to get as many sold by the 11/1 deadline for a spring setting. Here is a need for volunteers. There have been donations from the Lions, Band and Citizens Bank, and should hear soon about the \$10,000 grant for the bandstand ramp and other updates. New Business: Approved: Zoning Permit LAF 2022-10 for a fence. LAF 2022-08 Heimat Properties, LLC request for a simple lot split. Hippert explained the request, council approved and Walton will create a certification resolution to be added to the 8/15 special meeting along with the scheduled budget workshop. LAF 2022 09 Rezoning request for Heimat Properties LLC -Hippert explained that the use of the school building is limited, it needs to be put to a different use as it is not a good fit for residential development due to size limit and lack of access of utilities; council set the public hearing for the 9/12 council meeting. Council also approved 'Does not Waive' for the annual Liability Waiver, Resolution 2022-13 for August donations of \$1,128.67 including: \$765 from the band, and \$863.67 from the Citizens bank staff all for mini park updates for the ramp and bandstand materials, the request from 1st Lutheran to borrow picnic tables for 10/2 event, and contracting David Drown and associates to proceed with the pay equity

## Special Mtg and Budget Workshop: 8/15/2022

Guests present: D. Burger 580 Main Avenue

New Business: Approved Resolution 2022-14 In Matter of Property Located at 400 Wanser and Resolution 2022-15 Certification of Approval of Subdivision and also approved the first reading of Ord. 19 – An Interim ordinance Amending the Zoning Code: In review of the Zoning code adopted in 1990 council determined that the zoning code would better serve the City and members of the public if it contained specific criteria for examining and deciding on applications to rezone land and change zoning. This amendment contains a process for staff and council to follow when a rezoning application is received, (the full ordinance is posted on the website). Budget Workshop: After reviewing of all departments needs and wishes for the 2023 budget year, council felt that a preliminary levy amount of an \$41,111.00 or 21.98% increase was a good place to start, being all costs of goods and services have increased. Some items included in the increase: more council meetings due to the RO project for 2023, increased training for new firefighters, overhead door replacements for the fire barn, fixing the east end of Pioneer Avenue to curb and gutter to eliminate continuing issues. Culture items: discussed contracted mowing vs purchase & doing inhouse mowing, mini park updates, wish projects for Lund park update backstops, slab by pop shack, community center a new exhaust fan. A Resolution to approve the Preliminary Levy and 2023 budget will be an agenda item for the 9/12 council meeting. Enterprise Funds: Water discussed the water loan from the sewer fund when the new well was needed. The RO project is due to the Chloride levels in the sewer waste, but the only fix is the source water. The Preliminary Levy is always higher and possible cuts can be made before the final Levy is set in December. There will be another budget workshop in December prior to the final levy is approved. Next meeting: Monday, September 9, 2022, @ 7 pm meeting in the Council Chambers 791 Main Avenue.
